Minutes of the September 12, 2003, Meeting

- **Secretary**: The Minutes of the August 2003 meeting were submitted and approved as perfected.
- Treasurer: The Treasurer's Report for August 2003 was approved, subject to audit.
- **Registrar**: Compatriot Risley reported that five new members have been approved thus far this year and that five new membership are pending with the National Society. Seven prospective members are completing applications.
- Eagle Scouts: Compatriot Risley represented the Patton Chapter at an Eagle Scout , Court of Honor in Simi Valley on June 26.

- Awards Nominations: Compatriot Coffman moved and Compatriot Risley seconded a
  motion to award the Law Enforcement Medal to a deserving member of the Ventura
