11 August 2017 Meeting Minutes

The regular monthly luncheon meeting of the General George S. Patton, Jr., Chapter SAR was held Friday, 11 August 2017, in the Garden Room of the Marie Callender's Restaurant, 1295 S. President Lynch as interim Treasurer presented the Treasurer's report, which was accepted as presented.

Old and New Business:

Chaplain Taylor reported sending cards to Compatriots Ward White, George Horne, Gene Cooper, and Russ Ireland. Chaplain Bob solicited prayers for those with issues, and encouraged the members to let him know of illnesses and problems among the membership.

Color Guard Commander Taylor had nothing to report.

Secretary Taylor reported on the ceremony for Compatriot COL. Marty Spann, who was awarded with a Bronze Star with Valor for his actions in Iraq 11 Mar 2005. It was a distinct honor for the chapter to have been invited to the ceremony at the Museum of Military History in Simi Valley.

VP South Taylor noted the invitation given during the 127th NSSAR Congress for a special ceremony commemorating 100 years since the end of WW I to be held in France 10-17 June 2018.

VP South Taylor noted the Orange County Chapter will be celebrating their 50th anniversary with a picnic at Mile Square Park in Fountain Valley 19 August, and encouraged the members to attend.

VP South Taylor mentioned the 2019 NSSAR Congress will be held in Newport Beach/Costa Mesa, and has raffle tickets for the patriotic quilt to be raffled off to help defray expenses.

President Lynch announced the CASSAR Fall Board of Managers meeting will be held this November in Irvine, and encouraged participation by the members.

There was no new business.

President Lynch noted he still needs program speakers for October and November, which elicited several suggestions: Bill Hurley will pursue a speaker (Daughters of Union Veterans, quartermaster), former CASSAR President Steve Hurst has a CD regarding America's Founding Father and mentioned John Calvin Brewster, early resident of Ventura and descendant of William Brewster of the Mayflower (Ward White & Peter Bueschen are descendants), and Robert Dempster was suggested (Peter Bueschen will followup). Marty Spann volunteered to speak in November on "Prison Ships during the American Revolution".

Business meeting was recessed for lunch.

Program:

The program "National Cemeteries" was presented by President Ken Lynch, which was informative, interesting and well received by the Chapter members and guests. Certificates of Appreciation were presented to Ken and to Eric Stassforth for last month's program.
